

Four (4) Director seats are up for election, as well as sixteen (16) seats and eight (8) alternate seats on the Nominating Committee.

Election ballots will be mailed and emailed to all voting stockholders following the annual meeting.

Attendance at the annual meeting is not required to vote. More information on this process is included in the voting information section of this meeting notice.

VOTING & REPORTING INFORMATION

ELECTION OF DIRECTORS

There will be four (4) Director seats, sixteen (16) Nominating Committee seats, and eight (8) alternate Nominating Committee seats on the Ballot that will be mailed following the Annual Meeting.

VOTING ELIGIBILITY

Stockholders entitled to vote ("C" stockholders) will be mailed a ballot following the annual meeting.

As of June 30, 2024, the number of "C" stockholders entitled to vote is 21,517. All "C" stockholders of record on July 31, 2024 will be eligible to vote for all seats. A majority vote of stockholders present is required in all elections.

BALLOTING

All voting for Directors and Nominating Committee members shall be by mail or electronic ballot. The ballot will be sent to each Class "C" stockholder by mail and by e-mail (for those with a valid email on file with AgSouth) within ten business days following the Annual Meeting. Biographical information on Director nominees will be included with the ballot. The election polls will be closed at the end of the twentieth business day following the date on which

ballots are sent to the voting stockholders. After the polls are closed, an independent third party will tally the ballots. The results of the election will be announced within ten business days. The ballots shall be retained with AgSouth's vendor, Survey & Ballot Systems, from Eden Prairie, Minnesota until the end of the term of the elected Directors and promptly destroyed thereafter.

DISCLOSURE INFORMATION

(FCA Regulation 620.21)

AgSouth Farm Credit, ACA has had loans outstanding and other transactions during the last full fiscal year-to-date to its senior officers, Directors and Director nominees, their immediate family members and organizations with which such senior officers, Directors or Director nominees are affiliated. These loans were made in the ordinary course of business and were made on the same terms (including interest rate, amortization schedule and collateral) as those prevailing at the time for comparable transactions with other persons.

No loan or other transaction to a senior officer, Director, Director nominee

or to any organization affiliated with such person, or any immediate family member who resides in the same household as such person or in whose loan or business operation such person has a material financial or legal interest, involved more than the normal risk of collectability.

We are required to report if any incumbent Directors attended less than 75% of Board meetings during 2023. Dr. Alton Thompson attended 71% (5 of 7) of Board meetings, and 67% (4 of 6) of Governance & Ethics Committee meetings.

Since publication of the annual report, no Director or senior officer has had any involvement in legal proceedings that require disclosure.


No Director resigned or declined to stand for re-election since the last annual meeting because of policy disagreements with the Board.

"The main farm I currently cultivate was started as a family venture between my father and his uncles to experiment with the growing of evergreen trees as a specialty commodity. That endeavor was so successful that my father planted the entire acreage in Fraser Fir Christmas trees and used his son, me, as free labor. I have been working these trees and land since I was twelve years old.

After graduating from Appalachian State University with a BS in Business Administration in 1990, I began my career as a full-time farmer. We employ mostly hispanic men through the H2-A Federal Work Program. Many of our workers have been with us for 20+ years. Working so closely with them, I have been able to learn the Spanish language, something I am very grateful I can do, to communicate our needs and learn their needs and expectations.

In 2008, my wife and I purchased the business from my father, and with the hindsight of today, it was indeed a most difficult journey. We decided to diversify a bit and added greenhouse production of Fraser Fir seedling and plug transplants in soil-less media, above ground in styro-block trays. We also expanded our Balled and Burlaped inventory and production as well as resumed operations of our Christmas tree retail lot.

Both my wife and I have had leadership roles and are very active within organizations pertaining to our business, namely, the North Carolina Christmas Tree Association and the Ashe County Christmas Tree Association. I believe that by collaborating and sharing knowledge we all benefit.

Both of our children, and their spouses, came back to the family business after graduation from college, and are currently overseeing various parts of the daily operations. It is my hope that they will continue to farm here in our beautiful county and enjoy the fruits of their labor to support their families and any future generations that may follow. I have always considered it an honor and privilege to live in the place where so many generations before me have farmed the land and lived peaceful, productive lives. I believe the continued stewardship of the land should be our highest priority."

"Born a farmer in 1983. Dad was one of over one-hundred functioning dairy farms in Alleghany County. He was milking 100 – 125 head of holsteins twice daily along with raising 200 head of sheep and 50 head of beef cows for a cow calf operation. In 1992 we had to sell the dairy to pay loans and that's when we went strictly to beef production and increased the herd to almost 200 before markets broke in the late 90's and early 2000's. Our current status is 70 head of mostly angus and semi-angus cows with a registered angus bull every couple years to get replacement heifers. We harvest about 250 rolls of orchard grass hay and 2,500 square bales annually. We also harvest 30 acres of wheat that we make haylage out of each year to supplement winter feeding. Family owned and operated; we all work together to make our family farm."
